MEETING MINUTES:

Motion to approve March 10, 2025 monthly meeting minutes were made by Supervisor Croker, seconded by Supervisor Shreve. With all Supervisors voting yes, motion carried.

GENERAL FUND BILL LIST HAVING A TOTAL OF \$53,056.51:

Motion to pay the general fund bills was made by Supervisor Mason, seconded by Supervisor Shreve. With all Supervisors voting yes, motion carried.

TREASURERS REPORT:

Motion to accept the Treasurer's report as presented was made by Supervisor Croker, seconded by Supervisor Mason. With all Supervisors voting yes, motion carried.

CURRENT BUSINESS:

Discussions:

- New/updated agreement made with Tri-County Surge girls softball league for continued use and upgrades to the township ballfields through 2029 ball season.
- Justen Anderson – notification of appointment as Emergency Management Coordinator for Bloomfield Township by Governor Josh Shapiro
- Bloomfield Township is participating in the county wide seal coat bid to be awarded later this month; our level of service has not yet been defined.

NEW BUSINESS:

Motion was made by Supervisor Croker, seconded by Supervisor Mason to award the bid price of \$14.99 per ton for 10,000 tons of 2RC gravel to Hasbrouck Sand and Gravel. With all Supervisors voting yes, motion carried.

- Bids received:
 - Al Construction: \$19.40 per ton = \$194,000
 - Glen O Hawbaker: \$18.72 per ton = \$187,200
 - Hasbrouck Sand and Gravel: \$14.99 per ton = \$149,900
 - ACA Sand and Gravel: \$17.21 per ton = \$172,100
 - Allegheny Aggregate: \$19.73 per ton = \$197,300

Motion was made by Supervisor Croker, seconded by Supervisor Shreve to award the bid price of \$.38 per gallon for 130,000 gallons of salt brine for a total of \$49,400 to Dodson Trucking. With all Supervisors voting yes, motion carried. No other bids were received.

The Supervisors discussed the use of cameras for assistance in managing storm water and lake levels

PUBLIC COMMENT:

Rich Chavlovich commented on the marker buoys at the coffer dam. Supervisor Mason explained that they were provided by the PA Fish Commission and placed by our road crew.

*****REC. BOARD*****

*****SEWAGE AUTHORITY*****

Rich Chavlovich reported that the Authority is implementing stricter methods of collection through their Solicitor. Delinquent accounts holders will have to pay their account balance, late fees, administration fees and all legal/court filing fees. Currently, there are four properties in the final stage of collection: a default judgment in the Court of Common Pleas.

Rick Makohus stated the number of permits has increased brought about by nice weather.

Supervisor Shreve stated that the road crew have been maintaining the dirt roads making them passable; plows have been removed, and grading will commence weather permitting.
